Any cancellation received less than 45 days from departure date is non refundable. Any mistake or error in Tour documents issued by or through Al-Mu'adhdhan must be immediately reported to Al-Mu'adhdhan. The failure to give Al-Mu'adhdhan a reasonable opportunity to correct any mistake prior to the commencement of the Tour shall be deemed a waiver of the right to any damages or reimbursement resulting from any such error and the Client will be obligated to pay any additional expense resulting from such error.
